**(B)(i) The proposal of Adarsh Institute of Technology and Research Center, Vita, Sangli (EN6304) for approval of fees for the academic year 2024-2025.**

Discussed.

While examining the proposal it is noticed that the Institute has charged and collected the fees over and above the fees approved by Authority. It was therefore decided to call the explanation of the Institute and the reconciliation statement of fees charged & collected by the Institute. The Institute be directed to report the compliance within seven days.

**(ii) The proposal of Terna Public Charitable Trust's College of Engineering, Osmanabad (EN2130) for approval of fees for the academic year 2024-2025.**

"Discussed.

The Institute has not complied the direction to submit the copy of Form No. 16 (i.e. Traces of Form No. 16 downloaded from the site of Income Tax) in respect of employees. The Institute be directed to make compliance within seven days.

**(iii) The proposal of G.H.Raisoni College of Engineering & Management, Wagholi, Pune (EN6155) for approval of fees for the academic year 2024-2025.**

"Discussed.

While examining the proposal it is noticed that the entire non salary expenditure have been loaded on B.Engineering course & claimed 'No Upward Revision' of fees in respect of M.B.A & M. Engineering courses for the academic year 2024-2025. It was necessary on the part of the Institute to follow the norms and shown the segmental bifurcation of income and expenditure of all the courses while submitting the proposal. It was not proper on the part of the Institute to act in gross violation of norms prescribed by the Authority in respect of submission of the proposal to show segmental bifurcation of expenses. It was therefore decided to direct the Institute to submit the coursewise segmental bifurcation of income and expenditure in respect of B. Engineering as well as M.Engineering, M.B.A & M.C.A courses even if the Institute has claimed no upward revision of fees for the academic year 2024-2025. So also, the copy of Audited Financial Statement of the academic year 2022-2023 in respect of M.B.A & M. Engineering courses also be furnished. The compliance be made within seven days.

**To consider the proposal of Sushrusha Institute of Nursing Sciences Pune (PBSCN0019) for approval of fees for the academic year 2023-2024 in respect of B.Sc.(Nursing) & P.B.Sc.(Nursing) Courses run by the Institute.**

"Discussed.

After considering the proposals, the documents submitted and the course wise segmental bifurcation of income and expenditure in respect of which the fees to be approved as well as the other courses run by the

It was noticed that though the Institute is running M.Sc.(Nursing) course from the academic year 2020-2021 the Institute has not submitted the proposal for approval of fees. In terms of Sec. 14(1)(a) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (hereinafter referred to as the "said act of 2015"), the Institute was under legal obligation to submit the proposal for approval of fees for the academic year 2022-2023 and approval & finalization of adhoc fees for the academic year 2020-2021 & 2021-2022. Incase the Institute had not secured admission in the academic year 2020-2021 then atleast the proposal ought to have been submitted for approval of fees for the academic year 2023-2024 and finalization & confirmation of adhoc fees for the preceding two years. By committing default in submitting the proposal as per the mandate of Sec. 14(1)(a) of the Act of 2015, the Institute has prima facie invited penal consequences u/s. 20 of the Act of 2015. It was therefore decided to issue show cause notice to the Principal of the College & Management running the Institute to offer explanation as to why an action u/s. 20 of the Act of 2015 may not be taken against the Institute. The Institute be directed to offer the explanation within seven days.

**To consider the online intimations received from Unaided Institutions i.e. Private Professional Educational Institutions to opt for 'No Upward Revision' of fees for the academic year 2024-2025.**


